**Call to Order:** Tim Jones called the meeting to order with a quorum at 8:03 a.m.

**Approval of Minutes:** Minutes from the December 7, 2017 meeting were presented. Mr. Bautz moved that the minutes be accepted as written. Ms. Lev seconded the motion, which passed by a unanimous vote.

**Guest Speaker Series, Talbot County Free Library:** Dana Newman, Library Director  
Ms. Newman gave a presentation on the 2017 Annual Report of the Library.
