Talbot County Tourism Board Meeting Minutes February 8, 2023

I. Call to Order

The Tourism Board met via Zoom videoconference. Chairman Judy Bixler called the meeting to order at 8:33 a.m.

II. Approval of Meeting Minutes – January 11, 2023

Ms. Bixler presented the minutes from the January 11, 2023, meeting. Mr. Fleming made a motion to approve the minutes with Ms. Kellogg seconding the motion. Motion passed unanimously.

III. Special Guest – Patrick Rofe, St. Michaels Community Center, Hospitality Training Program

Mr. Rofe expressed thanks to community for support of the St. Michaels Community Center capital campaign. As quantified through community surveys, the center has developed a workforce development program with an advisory committee, and in partnership with Chesapeake College. The emphasis is on the 12-week culinary training along with life skills and is open to all Talbot County adults. The program will also expand to include front of house training starting with server and bartender tracks. Internships will be available.

IV. Chairman's Report – Judy Bixler

Introduction of New Board Member: Ms. Bixler welcomed new Tourism Board member Tad DuPont, St. Michaels Town Commissioner.

Taste of the Eastern Shore, February 9: Culinary event with state legislators. Ms. Bixler and Ms. Vanhooser will attend.

Tourism Day, February 10: This is a day of advocacy for the industry statewide. Ms. Bixler and Ms. Vanhooser attend on behalf of Talbot County.

V. Director's Report

Visitors Center Construction: Ms. Vanhooser explained that the Town of Easton will begin construction on the historic building at 11 S. Harrison Street that currently houses the Talbot County Visitor Center. She asked for discussion and guidance on how the board would like to proceed regarding the future of the Visitor Center. After discussion concluded, Mr. Schneider made a motion to launch the feasibility study with Ms. Bellis amending the motion to include that current Talbot County Visitors Center staff vacate the current location. Ms. Greenaway second the motion, which passed unanimously.

Visitor Center Feasibility Study: Ms. Vanhooser reported that the Request for Proposal is being drafted.

Frederick Douglass Website: Ms. Vanhooser reported that she has worked with The Design Minds to bring the current FrederickDouglassBirthplace.org website into alignment with the branding at the park and on the new Map/Guide. The site will launch within the next month.

Bike Map Redesign: Talbot Thrive, a group that advocates for safe multimodal transportation alternatives, has approached Ms. Vanhooser about redesigning the Talbot County Bike Map. This project will take place within the coming year.

Byway Meeting: The nine counties on the Eastern Shore along with the three Heritage Areas have formed an alliance and are working on an interpretive plan for the Chesapeake Country All-American Road. That project should be completed early in 2023. Talbot County will host the Mid-Shore's public meeting in March.

VI. Manager's Report

TourTalbot.org Website Launch: Ms. Boothby stated that the updated website launched on January 17 and is running smoothly. She noted that event producers can begin submitting events via the "Submit Your Event" link on the site's footer.
